Generalized Anxiety Disorder (DSM-IV-TR #30002) Generalized anxiety disorder (GAD), also known as "chronic anxiety neurosis," is characterized by chronic "free-floating anxiety," accompanied by such autonomic symptoms as tremor, tachycardia, and diaphoresis The lifetime prevalence of generalized anxiety disorder has
